


Paul Winklebleck Kidnap & Death Investigation

Paul Winklebleck had a charismatic personality that disarmed people and kept them from seeing his darker underpinnings. In truth, he was a violent sexual predator and ex-con. In March of 2010, Winklebleck abducted two young women from downtown Portland at knife point, made them take drugs, beat them, and drove them toward a remote area near Detroit Lake to rape and most likely kill them. The victims courageously kept their wits and managed to fight back and fight for their lives. They are alive – he is not.

Portland Police Bureau Detectives Michele Michaels and Bryan Steed present this fascinating and difficult case that spanned four years and made national headlines. Forensic Anthropologist for the Oregon State Patrol Medical Examiner's Division, Dr. Nici Vance, will present the human remains and identification portion of the case.



Lori Billingsly Rape & Murder



On October 9, 1982, 17-year old Lori Billingsley was last seen walking from her mother's apartment in Aloha, Oregon, to the nearby Safeway store. Her nude body was found the next morning in a ditch. Billingsley had been brutalized and sexually mutilated. The initial investigation was intensive but did not result in an arrest.

This investigation continued off and on for the next three decades. Numerous suspects were considered, including Gary Ridgeway and Alvin Brown. From 1982 to 2009, it was believed there was no DNA evidence. Then in 2009, after evidence had been reexamined for the third time, it was discovered there was in fact DNA from the victim's autopsy. The DNA profile did not match any profile in the CODIS database though.

The case was reopened and the suspect, Kenneth Lee Hicks, was arrested in 2013. After a hotly contested two and a half week trial, Kenneth Lee Hicks was convicted of aggravated murder in July of 2015.

Numerous issues made came into play during the final investigation and trial. The original lead detective was now deceased, witnesses who were 12 years old at the time of the murder no longer had an independent recollection of events from 1982. The scale of the investigation over three decades provided the defense with numerous red herrings. Some witnesses had passed on. Three lab reports stating there was no DNA had to be explained. This case became an exercise in history.

Animal DNA from dog hairs was used for the first time in Washington County.

Christmas Murder of Jamie Lyn Larson

On December 25, 2012, the bound and gagged body of Jamie Lyn Larson was found in the bathtub of her Portland apartment. After clearing her live-in boyfriend and acquaintances, detectives focused on her timeline of events Christmas Eve. Larson had been out drinking, eventually meeting up with Michael Kirkland. They ended up at Larson's apartment where she was raped, sodomized, and strangled.



Portland Police Bureau Detective Sergeant Molly Daul presents this difficult case, from developing a suspect to taking down this opportunistic sexual predator. A concerning and interesting activity was learned about the suspect after his arrest.

Kelly Vern Swoboda – Kidnap, Attempted Cop Killer, Officer Involved Shooting



On January 27, 2014, serial bank robber Kelly Swoboda entered a Palm Beach tanning salon and abducted the lone female employee. After bludgeoning the victim, Swoboda dragged her to his van and bound her with duct tape. The victim was able to escape by jumping out of the moving van, where citizens found her badly injured. A multi-state manhunt ensued. Swoboda was located by Portland Police School Resource Officer John Romero, while he was seen watching Wilson High School students walk to school. When Officer Romero attempted to stop him, Swoboda pulled out a gun and shot Officer Romero, who returned fire.

Portland Detective Erik Kammerer presents this unbelievable case involving a true predator. Officer John Romero will present as well, discussing the contact with Swoboda, along with the aftermath of the officer involved shooting.
