

Instructors will present **SEVERAL** Officer Involved Shootings & Homicide Case Studies.

**Officer Involved Shooting Case Study:** In 2011 two officers were shot while attempting to make a traffic stop on a suspicious person. What occurred over the next five minutes changed the lives of many people. Detectives Martin and Butcher will provide a step by step look at the investigation from the beginning to the conclusion of the trial. Additionally the presentation will contain interviews of the officers involved in the shooting and how the shooting has affected them. Two other Officer Involved Shooting Case Studies will be presented.

**HOMICIDE CASE STUDIES:** Detectives will provide a case on a gang related case study where the victim was carjacked, kidnapped, and left for dead, a case study about the senseless murder of an elderly man out for a walk, and a drive by shooting involving a young girl.

The investigations and topics covered will be accompanied by power point presentations to include photographs, portions of recorded interviews, crime scene diagrams, jail calls, etc.

OFFICER INVOLVED SHOOTINGS HAVE BEEN ON A RISE IN PHOENIX OVER THE PAST TWO YEARS AND CURRENTLY ARE OCCURRING MORE FREQUENTLY THAN HOMICIDES.

**ABOUT THE SPEAKERS:** DETECTIVES MARTIN AND BUTCHER WERE PARTNERS FOR SIX YEARS AND INVESTIGATED SEVERAL OFFICER SHOOTINGS. DETECTIVE JAN BUTCHER IS A 20 YEAR VETERAN OF THE PHOENIX POLICE DEPARTMENT. DURING HER TENURE WITH THE DEPARTMENT, SHE SPENT THREE YEARS IN PATROL, SIX YEARS IN THE MISSING PERSONS BUREAU AND THE LAST ELEVEN YEARS AS A HOMICIDE DETECTIVE. DETECTIVE BUTCHER INVESTIGATES NOT ONLY HOMICIDES AND OTHER DEATH INVESTIGATIONS, BUT OFFICER INVOLVED SHOOTINGS AS WELL.

DETECTIVE KARL MARTIN IS A 27 YEAR VETERAN OF THE PHOENIX POLICE DEPARTMENT. DURING HIS TENURE WITH THE PHOENIX POLICE DEPARTMENT HE HAS BEEN AN INVESTIGATOR IN THE FOLLOWING DIVISIONS: GANG SQUAD, ROBBERY, SPECIAL INVESTIGATIONS, SEX CRIMES, EMPLOYMENT SERVICES, AND HOMICIDE.
