# *LOOMIS GUARD HOMICIDE*

April 25, 2013

On June 2, 2009 a Loomis Armored car guard exited the Anchor Bank located inside the Lakewood Washington Walmart. The guard was shot and killed execution style by the suspect who laid in waiting. The suspects took the deposit bag and fled the store in a stolen vehicle. This incident led to a multi agency police response and manhunt which eventually led to the arrest and prosecution of two suspects. Investigators from the Lakewood Police Department will walk participants through a forensic review of the crime and the criminal investigation that followed.

- Challenges with the coordination of a multi-agency response involving local, county and federal law enforcement agencies.
- Coordination of multi-jurisdictional resources.
- Forensic analysis of the criminal investigation.
- The role video evidence played in the investigation.
- Prosecution overview.
