

Clandestine Laboratory 40 hour Operations & Safety Course

Cancellation Policy: All confirmed spots in this class are considered non refundable after March 24, 2014. It is the responsibility of the agency sending a student to find an appropriate replacement and notify CADRE

Who: This class will be limited to the first 32 law, or fire hazmat response officials who confirm slots. Prior HazMat training would benefit the student. Commissioned Law Enforcement or Fire/Hazmat officials who support Law Enforcement are authorized to attend. Previous students have come from several states, Canada and Taiwan. Other individuals will need to be approved on a case by case basis prior to reserving a spot. Contact Dave Kummerlowe w/CADRE if you have questions.

Where: Washington State Patrol Fire Training Academy, North Bend, WA. Don't bother trying to 'mapquest' the address. Follow the directions below:

Eastbound - take exit 38 off I-90, turn right off the exit. The road will run parallel to the freeway approximately two miles, then curves left back under the freeway and through a yellow pole gate. Follow the one lane access road approximately 2.5 miles to the Fire Training Academy Hazmat Building (large metal building with overturned highway trailers and a railcar outside). Park on the north side of the Hazmat Building

Westbound - take exit 38 off I-90, turn right off the exit. Follow road through the yellow gate to access road. Follow the single lane access road approximately 2.5 miles to the Hazmat Building (large metal building with overturned highway trailers and a railcar outside). Park on the north side of the Hazmat Building.

Prerequisites:

1) All participants are required to be cleared by their employer for physically demanding work wearing personal protective equipment in accordance with WAC 296-824-40005.

This is considered mandatory by CADRE (per the WAC) and confidential between the employer and employee. No paperwork is required to be submitted to CADRE.

2) No beards or facial hair (most mustaches are OK) that interferes with a face piece seal is allowed.

Agenda: This class is designed for the law or fire/hazmat official who will be entering, securing the premise and obtaining evidence at clandestine drug laboratories. It consists of substantial hands on activities including clan lab terminology, recognition, chemistry, recipes, cooking techniques, monitoring instruments, selection and wearing of personal protective equipment, APR fit testing, investigative methods, incident command, decontamination, site control, site safety and hazard analysis. It meets the requirements of WAC 296-843-20010 for illicit drug lab responders who require 40 hours of training.

What to bring: Starting on Monday bring 1) a change of clothes & 2) Self Contained Breathing Apparatus, 1 per student, spare bottle preferred but not mandatory, refill capability is onsite. E-mail or call Dave Kummerlowe if you are not able to provide one SCBA for each student from your organization. Heavy clothing & work gloves for Tue PM paintball is highly recommended to minimize welts! If you want individual instruction on the use of your air monitoring instrumentation, bring it.

Accountability: Students will be held accountable through daily quizzes, hands on practical exams and a final written test. Students who successfully complete these exercises and have 100% attendance will receive a certificate of completion for the course. Others will receive a certificate of attendance for the hours attended.

Deliverables: Each student will receive a CADRE clan lab student manual, Certificate, wallet card & safety glasses. Chemical protective suits, gloves & boots will be provided during the class for hands on exercises.

Food: coffee, am/pm snacks & lunch all 5 days is provided by CADRE.
