<b>Firearms:</b>	<ul style="list-style-type: none"><li>• Bolt action or Semi-Auto Rifle<ul style="list-style-type: none"><li>○ Minimum caliber .308.</li><li>○ Rifle will have a trigger pull of no less than 3 lbs.</li><li>○ Rifle must be capable of firing a 4-shot group from 100 yards that measures 1" or less.</li></ul></li><li>• All rifles must have a scope that is capable of magnification.</li></ul>
<b>Attendance:</b>	100% attendance required. (Emergency situations will be reviewed on a case by case basis.)
