“Operation Red Light”

Training Overview:

Operation Red Light began as an investigation into vice crimes in and around the Northern Quest Casino. Once launched the investigation uncovered a web of criminal activity well beyond the culture of prostitution. The investigative scope of this operation expanded, revealing that involved parties were upscale community members, defense attorneys, a prosecutor and law enforcement officers. It was determined that a “Special Inquiry Court” would be convened to support this operation. In totality, Operation Red Light culminated into over a three year multi level investigation involving local, state, federal and tribal law enforcement agencies in the greater Spokane area.

This Lessons Learned training will provide insight into:

- Challenges with the coordination of a multi-agency response involving local, county, tribal, and federal law enforcement agencies.
- Understanding of Special Inquiry Courts (Washington State).
- The coordination of 200 Law Enforcement Officers on take down day.
- Forensic analysis of the criminal investigation and financial investigation.
- Money laundering / Seizure and forfeiture.
