



## AMBER/EMPA –WA State Plan Training

The Washington State Patrol will be presenting training on the on the Washington State AMBER Alert Plan criteria for entry and process improvements made for 2014. Training will also cover the Endangered Missing Persons Advisory Plan (EMPA) and how and when to activate. The LEAP system has been upgraded and a new process for local agency entry will be covered in detail.

During this training we will also discuss differences between AMBER and EMPA and the differences in alerting methods for each. Best practice recommendations will be discussed and questions clarifying criteria will be addressed.

The Washington State Patrol Missing and Unidentified Persons Unit (MUPU) also acts as the Washington State Missing Children’s Clearinghouse. Responsibility for coordinating AMBER and EMPA has been assigned to the manager of MUPU. We will discuss, briefly the role of the Clearinghouse in missing children cases and a quick overview of the MUPU and its function as the state repository for dental records for all missing and unidentified persons in Washington.

**Audience:** Law enforcement officers and detectives, dispatchers, and records personnel that will be communicating with WSP Communications or the media regarding entries, updates, and cancellations of AMBER alerts and/or Endangered Missing Persons Alerts, and those who investigate or enter missing or unidentified person’s records.
