<b>Course Materials:</b>	<ul style="list-style-type: none"><li>• <b>Students are required to download or print the manual.</b> It is the students responsibility to have the manual available to them on the first day of class. A link will be sent one week prior.</li><li>• A passing score on the qualification shooting test will be needed for course completion.<ul style="list-style-type: none"><li>○ <a href="#">25 yard Qual</a></li><li>○ <a href="#">50 yard Qual</a></li><li>○ Skill Test is attached</li></ul></li></ul>
<b>Attire:</b>	<b>Suitable clothing for range training in an outdoor environment.</b>
<b>Equipment Needs:</b>	Note-taking items such as notebook paper, pens, and pencils, will not be made available at the training site, and are the responsibility of each attendee. <b>REQUIRED</b> equipment for EACH student: <ul style="list-style-type: none"><li>• Agency issued/approved rifle with agency optics and iron sights or just iron sights, sling (recommend tactical), optional light mount. All applicants will bring a duplicate spare rifle in case of weapon malfunction.</li><li>• Spare magazine carrier (either belt or weapon mounted)</li><li>• Minimum of 3 rifle magazines.</li><li>• Dummy training rifle with sling (red or blue plastic – ASP or Ring’s).</li><li>• Duty handgun and Patrol duty belt with a minimum of 3 pistol magazines.</li><li>• Eye protection (including clear glasses for night firing).</li><li>• Hearing protection – electronic headphones and earplugs.</li><li>• One duty flashlight and one backup.</li><li>• BDU type pants with cargo pockets.</li><li>• Baseball cap.</li><li>• Body armor.</li><li>• Laptop.</li></ul>

	<p><b>Recommended equipment:</b></p> <ul style="list-style-type: none"> <li>• Rain poncho/parka.</li> <li>• Water bottle.</li> <li>• Knee pads.</li> <li>• Elbow pads.</li> </ul>
