**Casey Anthony Missing Person and Murder Investigation**

Major Ron Stucker, Florida Orange County Sheriff's Office, will present the case study of the Casey Anthony missing person and murder investigation. It will focus on investigative strategies, key points and lessons learned. Specific areas that will be addressed in the presentation will be interaction with the media on a case with international attention, search strategies, managing tips, the use of technology in the investigation and innovative forensic techniques.

**Reynolds High School Active Shooter Case**



On June 10, 2014, a Reynolds High School freshman rode the bus to school carrying a guitar case and duffel bag. The freshman armed himself and fired upon fellow students and Reynolds staff. Troutdale Police Department Detective Greg Vining and Multnomah County Sheriff's Office Detective Kevin Odil present this active shooter, murder, and officer involved case from initial 911 call to evacuation, reunification, and investigation. Oregon State Police Crime Lab Forensic Scientist and Crime Scene Analyst Devon Sommer presents on the scene processing and collection. Troutdale Police Department Chief Scott Anderson and Lieutenant Joel Wendland will comment and answer questions on the initial tactical response and aftermath of this school shooting case.

**Officer Down: The Robert Libke Incident and Aftermath**

Shortly after 1 p.m. on Sunday, November 3, 2013, a house fire was reported at 841 Linn Avenue in Oregon City, Oregon. During the initial dispatch, a report was broadcast of an armed male at the fire scene. Oregon City Police and Clackamas Fire District #1 crews were dispatched. One of the first police units to arrive was a two-man car with one regular and one reserve Oregon City Police Officer. Officer Robert Libke, a 41-year old Reserve Police Officer was confronted by the suspect -- the suspect shot Officer Libke, who died from his wounds the next day. Robert Libke's wife was pregnant at the time of his death. The incident, media coverage, aftermath and the following year will be debriefed by the on-duty supervisor Sergeant Pat Lynch, PIO Sergeant Matt Paschall and Chief Jim Band.

## Oregon State Police DNA Update

Oregon State Police Forensic Scientist, Dr. Janelle Moore, will provide a short update following the DNA unit's implementation of Y-STR analysis and the High Throughput Property Crime project. The Y-STR analysis discussion will include successes and limitations of the technique including case results and testimony questions. Data gathered from the first year of the DNA unit's High Throughput Property Crime project in which we partnered with agencies to decrease analysis time on property crime cases will be presented.

## Panel Discussion on Defense Attorneys Pick Apart Police Cases

Pat Higgins is a former law enforcement officer and, like many retired officers, does some work in the private sector for defense attorneys. Mr. Higgins has agreed to be part of a Question and Answer session, giving law enforcement professionals insight into how defense attorneys go about dismantling prosecution cases.
