

**ABOUT THE CLASS:** MURDERS AND VIOLENT CRIMES OCCUR EVERY DAY IN THE UNITED STATES; THEY ARE REPORTED ON EVENING NEWS PROGRAMS AND IN HOLLYWOOD MOVIES. ALL TOO OFTEN THESE CRIMES GO UNSOLVED OR ARE NOT PROSECUTED. HOWEVER, ON OCCASION INFORMATION IS DEVELOPED BY LAW ENFORCEMENT AGENCIES REGARDING A PERSON WANTING TO CONDUCT A MURDER FOR HIRE. ONCE CONFRONTED WITH THIS SITUATION LAW ENFORCEMENT AGENCIES ARE OFTEN CAUGHT OFF GUARD IN TWO CRITICAL AREAS, INVESTIGATIVE AND LOGISTICALLY. MORE CRITICAL IS THE FACT THAT MANY LAW ENFORCEMENT AGENCIES DO NOT HAVE THE EXPERIENCE OR TRAINING TO CONDUCT MURDER FOR HIRE INVESTIGATIONS IN AN UNDERCOVER CAPACITY. HIS FIRST DETECTIVE ASSIGNMENT WAS AS AN UNDERCOVER DETECTIVE IN THE PHOENIX POLICE DEPARTMENTS POLICE DEPARTMENTS SPECIAL PROJECTS UNIT, WHICH SPECIALIZED IN THE INFILTRATION OF INDIVIDUALS AND GROUPS OF INDIVIDUALS TRAFFICKING IN STOLEN PROPERTY. IT WAS DURING THIS ASSIGNMENT HE WAS ABLE TO ESTABLISH RELATIONSHIPS WITH MEMBERS OF VARIOUS STREET GANGS, PRISON GANGS, AND CRIMINAL ORGANIZATIONS. AS A RESULT OF HIS INVESTIGATIONS MOST OF THE SUSPECTS RECEIVED EXTENSIVE PRISON SENTENCES  
DETECTIVE WARNER'S IS CURRENTLY ASSIGNMENT TO THE PHOENIX POLICE DEPARTMENTS CAREER CRIMINAL SQUAD. MEMBERS OF THIS UNIT ARE SELECTED BASED ON AN EXEMPLARY RECORD OF PREVIOUS UNDERCOVER, INVESTIGATIVE AND TACTICAL EXPERIENCE. CAREER CRIMINAL IS A HYBRID SPECIAL INVESTIGATIVE UNIT.
