

CITY OF PROSSER, WASHINGTON
CIVIL SERVICE TESTING
ESTABLISHING ELIGIBILITY LIST

The City of Prosser Civil Service Commission is now accepting applications to establish eligibility lists for the position of ENTRY LEVEL POLICE OFFICER, EXCEPTION ENTRY POLICE OFFICER, AND LATERAL ENTRY POLICE OFFICER. These positions are union and are classified as Fair Labor Standards Act non-exempt.

Entry Level Police Officer: An applicant who either has not held a police officer certification or such certification has expired and is not eligible to attend the Washington State Criminal Justice Training Equivalency Academy.

Starting Wage: \$3897/per month
Application Information: Interested Applicants must contact www.publicsafetytesting.com or 1-866-HIRE-911 to complete written and physical testing. Testing times and locations are available on their webpage.

Exception Entry Police Officer: An applicant who meets these minimum qualifications:

- 1) have completed the testing process and been hired by another agency/department with the State of Washington or another State, from a Civil Service Commission certified eligibility list of like process; and
- 2) must have successfully completed the probationary period with their current or previous law enforcement employer; and
- 3) must have been continuously employed by their present or previous employer as a law enforcement officer for not less than 12 months in Washington State; and
- 4) must have graduated from the Washington State Criminal Justice Training Academy for law enforcement or you must be able to challenge the process for an equivalency certification.

Starting Wage: \$4093 to \$4511

Lateral Entry Police Officer : An applicant that meets these minimum qualifications:

1) have completed the testing process and been hired by another agency/department with the State of Washington, from a Civil Service Commission certified eligibility list of like process; and

2) must have successfully completed the probationary period with their current or previous law enforcement employer; and

3) must have been continuously employed by their present or previous employer as a law enforcement officer for not less than 12 months in Washington State and must have been employed as a law enforcement officer within the last 24 months; and

4) must have graduated from the Washington State Criminal Justice Training Academy.

Starting Wage: \$4093 to \$4511
