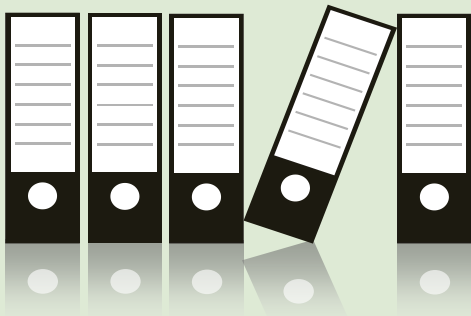

Instructors with the correct credentials and program issued photo ID are titled "Private Security Certified Firearms Instructors" pursuant to WAC 139-37.

Instructors that do not comply with program policies and WAC can be removed from the program at any time. Written complaints regarding instructors are to be sent via email to [pspi@cjtc.state.wa.us](mailto:pspi@cjtc.state.wa.us). All complaints received will be reviewed.

Instructors listed with Level 1 Scoped Rifle Instructor active status, may or may not be PS Certified Firearms Instructors as not a required part of RCW or WAC.

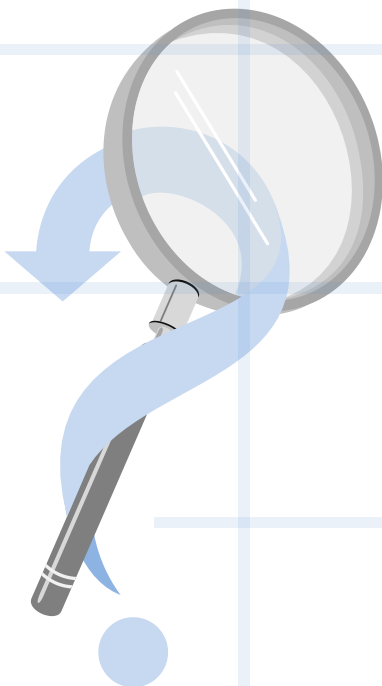
