WAC 246-808-700 Cooperation with investigation. The Chiropractic Quality Assurance Commission (CQAC) has determined that this rule is redundant due to the investigative requirements in RCW 18.130.230 and proposes repealing the rule.

**Purpose of the proposal and its anticipated effects, including any changes in existing rules:**

The proposal will repeal WAC 246-808-700 because the legislature granted statutory authority in RCW 18.130.230 to require all healthcare professions, including chiropractors, to produce documents requested as part of an investigation or be subject to a fine. RCW 18.130.230 is more specific than WAC 246-808-700 and controls the legal process for production of documents, so WAC 246-808-700 should be repealed.

**Reasons supporting proposal:**

RCW 18.130.230 governs the same activity as WAC 246-808-700, making the rule redundant, and therefore use of the expedited rulemaking process to repeal the rule is appropriate.
