<p>“Personal care services” means both physical assistance and/or prompting and supervising the performance of direct personal care tasks as determined by the resident’s needs, and does not include assistance with tasks performed by a licensed health professional. (WAC 388-76-10000)</p>

<p>If needed, the home may provide assistance with eating as follows: Cut, blend and feed the client as per assesment.</p>
<p>2. TOILETING If needed, the home may provide assistance with toileting as follows: Assistance with toileting is provided as need it during the day. At night toileting is scheduled.</p>
<p>3. WALKING If needed, the home may provide assistance with walking as follows: Assistance with walking is provided as need it .</p>
<p>4. TRANSFERRING If needed, the home may provide assistance with transferring as follows: The home has a hoyer lift for transferring and is used as the primary choice.</p>
<p>5. POSITIONING If needed, the home may provide assistance with positioning as follows: Assistance with possitioning is available as per assesment. Over night repositioning will be scheduled. No awake staff.</p>

(WAC 388-76-10040)

- The provider lives in the home.
- A resident manager lives in the home and is responsible for the care and services of each resident at all times.
- The provider, entity representative, or resident manager does not live in the home but the home has 24-hour staffing coverage, and a staff person who can make needed decisions is always present in the home.

Medicaid
