Personal Care

"Personal care services" means both physical assistance and/or prompting and supervising the performance of direct personal care tasks as determined by the resident's needs, and does not include assistance with tasks performed by a licensed health professional. (WAC 388-76-10000)

1. EATING

If needed, the home may provide assistance with eating as follows: preparation, consistency modification, intake monitoring

2. TOILETING

If needed, the home may provide assistance with toileting as follows: Awake hours only, peri care, transferring, output monitoring.

3. WALKING

If needed, the home may provide assistance with walking as follows: Stand by assist on uneven surfaces.

4. TRANSFERRING

If needed, the home may provide assistance with transferring as follows: Stand by assist

5. POSITIONING

If needed, the home may provide assistance with positioning as follows: every two hours/as needed.

6. PERSONAL HYGIENE

If needed, the home may provide assistance with personal hygiene as follows: shaving, Oral care, nail care when allowed. Bathing/shower assistance.

7. DRESSING

If needed, the home may provide assistance with dressing as follows: putting clothing on, tying shoe laces, buttons, monitor for appropriateness, (weather or event).

8. BATHING

If needed, the home may provide assistance with bathing as follows: full assistance as needed.

9. ADDITIONAL COMMENTS REGARDING PERSONAL CARE Clients must be ambulatory. Care will only be provided by routine unless other arrangements are made with staff.

Medication Services

If the home admits residents who need medication assistance or medication administration services by a legally authorized person, the home must have systems in place to ensure the services provided meet the medication needs of each resident and meet all laws and rules relating to medications.
