Personal Care

“Personal care services” means both physical assistance and/or prompting and supervising the performance of direct personal care tasks as determined by the resident’s needs, and does not include assistance with tasks performed by a licensed health professional. (WAC 388-76-10000)

1. EATING

If needed, the home may provide assistance with eating as follows:

Set-up, reminders, one person assist

2. TOILETING

If needed, the home may provide assistance with toileting as follows:

Reminders, one person assist; incontinence assistance

3. WALKING

If needed, the home may provide assistance with walking as follows:

Cueing, monitoring, one person assist; home is ramp accessible - limited ground floor bedrooms

4. TRANSFERRING

If needed, the home may provide assistance with transferring as follows:

Cueing, monitoring, one person assist

5. POSITIONING

If needed, the home may provide assistance with positioning as follows:

Cueing, monitoring, one person assist

6. PERSONAL HYGIENE

If needed, the home may provide assistance with personal hygiene as follows:

Set-up, reminders, cueing, monitoring, supervising, one person assist

7. DRESSING

If needed, the home may provide assistance with dressing as follows:

Set-up, reminders, cueing, monitoring, supervising, one person assist

8. BATHING

If needed, the home may provide assistance with bathing as follows:

Set-up, reminders, cueing, monitoring, supervising, one person assist

9. ADDITIONAL COMMENTS REGARDING PERSONAL CARE

Roll in shower, walk in tub

Medication Services

If the home admits residents who need medication assistance or medication administration services by a legally authorized person, the home must have systems in place to ensure the services provided meet the medication needs of each resident and meet all laws and rules relating to medications. Skilled Nursing Services and Nurse Delegation

If the home identifies that a resident has a need for nursing care and the home is not able to provide the care per chapter 18.79 RCW, the home must contract with a nurse currently licensed in the state of Washington to provide the nursing care and service, or hire or contract with a nurse to provide nurse delegation. (WAC 388-76-10405)

Staffing

The home’s provider or entity representative must live in the home, or employ or have a contract with a resident manager who lives in the home and is responsible for the care and services of each resident at all times. The provider, entity representative, or resident manager is exempt from the requirement to live in the home if the home has 24-hour staffing coverage and a staff person who can make needed decisions is always present in the home. (WAC 388-76-10040)

- The provider lives in the home.
- A resident manager lives in the home and is responsible for the care and services of each resident at all times.
- The provider, entity representative, or resident manager does not live in the home but the home has 24-hour staffing coverage, and a staff person who can make needed decisions is always present in the home.

The normal staffing levels for the home are:

- Registered nurse, days and times: **Nurse delegation comes as needed.**
- Licensed practical nurse, days and times: _____
- Certified nursing assistant or long term care workers, days and times: **2-3 Home Care Aides (HCA) live in the home; 2 additional HCAs work 30 - 40 hrs a week. Shifts vary; 1-2 people or more in the home at all times.**

Medicaid
