Personal Care

If needed, the home may provide assistance with walking as follows: *Assistance to wheel resident needs to ambulate to, inside AFH.*

4. TRANSFERRING

If needed, the home may provide assistance with transferring as follows: *Assistance, with transfer board, or hoist.*

5. POSITIONING

If needed, the home may provide assistance with positioning as follows: *As many times as required every 2-4 hrs.*

6. PERSONAL HYGIENE

If needed, the home may provide assistance with personal hygiene as follows: *All AOK to meet resident's needs.*

7. DRESSING

If needed, the home may provide assistance with dressing as follows: *total assistance required by resident.*

Staffing

The home's provider or entity representative must live in the home, or employ or have a contract with a resident manager who lives in the home and is responsible for the care and services of each resident at all times. The provider, entity representative, or resident manager is exempt from the requirement to live in the home if the home has 24-hour staffing coverage and a staff person who can make needed decisions is always present in the home. (WAC 388-76-10040)

- The provider lives in the home. *5 days of the week and staff (certified nurse or CNA) 2 days.*
- A resident manager lives in the home and is responsible for the care and services of each resident at all times.
- The provider, entity representative, or resident manager ~~does not live~~ *For 5 days on* in the home *24 hrs* but the home has 4-hour staffing *For 2 days* coverage, and a staff person who can make needed decisions is always present in the home.
