**Personal Care**

1. EATING

If needed, the home may provide assistance with eating as follows: We provide eating assistance from cueing and monitoring to total assistance. We provide special diet if needed.

2. TOILETING

If needed, the home may provide assistance with toileting as follows: We provide toileting assistance to all levels: cueing, assistance, catheter care.

3. WALKING

If needed, the home may provide assistance with walking as follows: We provide walking assistance from cueing and monitoring to a one or two person assist.

4. TRANSFERRING

If needed, the home may provide assistance with transferring as follows: We provide transfer assistance from cueing to monitoring, one or two person assist.

5. POSITIONING

If needed, the home may provide assistance with positioning as follows: We provide assistance with positioning from cueing and monitoring to a one or two person assist if necessary.

6. PERSONAL HYGIENE

If needed, the home may provide assistance with personal hygiene as follows: We provide assistance with personal hygiene from cueing and set up to total assistance.

7. DRESSING

If needed, the home may provide assistance with dressing as follows: We provide assistance with dressing from cueing and set up for total assistance.

8. BATHING

If needed, the home may provide assistance with bathing as follows: We provide assistance with bathing from cueing and set up to total assistance.

**Medication Services**

### Staffing

- The provider, entity representative, or resident manager does not live in the home but the home has 24-hour staffing coverage, and a staff person who can make needed decisions is always present in the home.
