Personal Care

1. EATING

If needed, the home may provide assistance with eating as follows:

2. TOILETING

If needed, the home may provide assistance with toileting as follows:

PROVIDE PARTIAL OR TOTAL ASSISTANCE TO THE TOILET & PROVIDE HYGIENE & CHANGE SOILED INCONTINENT PRODUCTS

3. WALKING

If needed, the home may provide assistance with walking as follows:

CAREGIVER WILL PROVIDE STAND-BY ASSISTANCE WHILE RESIDENT IS WALKING

4. TRANSFERRING

If needed, the home may provide assistance with transferring as follows:

PROVIDE ASSISTANCE DURING TRANSFER, BE IT 1 OR 2 PERSON OR MECHANICAL LIFT.

5. POSITIONING

If needed, the home may provide assistance with positioning as follows:

PROVIDE ASSISTANCE TO TURN IN BED & CHANGE POSITION DURING THE DAY.

6. PERSONAL HYGIENE

If needed, the home may provide assistance with personal hygiene as follows:

Medication Services

Skilled Nursing Services and Nurse Delegation

- The provider, entity representative, or resident manager does not live in the home but the home has 24-hour staffing coverage, and a staff person who can make needed decisions is always present in the home.
