## Personal Care

**As needed and as requested**

### 5. POSITIONING

If needed, the home may provide assistance with positioning as follows:

**2-3 hours if resident and family agrees.**

### 6. PERSONAL HYGIENE

If needed, the home may provide assistance with personal hygiene as follows:

**every 2-3 hrs around the clock**

### 7. DRESSING

If needed, the home may provide assistance with dressing as follows:

**As requested and needed**

## Medication Services

If the home admits residents who need medication assistance or medication administration services by a legally authorized person, the home must have systems in place to ensure the services provided meet the medication needs of each resident and meet all laws and rules relating to medications. ### Staffing

The home's provider or entity representative must live in the home, or employ or have a contract with a resident manager who lives in the home and is responsible for the care and services of each resident at all times. The provider, entity representative, or resident manager is exempt from the requirement to live in the home if the home has 24-hour staffing coverage and a staff person who can make needed decisions is always present in the home. (WAC 388-76-10040)

- The provider lives in the home.
- A resident manager lives in the home and is responsible for the care and services of each resident at all times.
- The provider, entity representative, or resident manager does not live in the home but the home has 24-hour staffing coverage, and a staff person who can make needed decisions is always present in the home.

The normal staffing levels for the home are:

- Registered nurse, days and times: **5 days /week 4 hrs**
- Licensed practical nurse, days and times: **5 days /week 12 hours**
- Certified nursing assistant or long term care workers, days and times: **7days/week 12hours**
- Awake staff at night
- Other:

ADDITIONAL COMMENTS REGARDING STAFFING

**Always 2 caregivers on staff and most of the time one of them is a RN or LPN ,awake caregiver at night.**

### Cultural or Language Access

**Medicaid**
