Medication Services

All medications are locked and stored for clients. Medications are administered as prescribed and if needed under the guidance of an RN nurse delegator.

Skilled Nursing Services and Nurse Delegation

If the home identifies that a resident has a need for nursing care and the home is not able to provide the care per chapter 18.79 RCW, the home must contract with a nurse currently licensed in the state of Washington to provide the nursing care and service, or hire or contract with a nurse to provide nurse delegation. (WAC 388-76-10405)

The home has the ability to provide the following skilled nursing services by delegation:

Mediation and treatments which are delegated by a RN contracted by the state including: medication administration, crushing of medications, blood sugar checks.

Staffing

The provider, entity representative, or resident manager is exempt from the requirement to live in the home if the home has 24-hour staffing coverage and a staff person who can make needed decisions is always present in the home. (WAC 388-76-10040)

- The provider lives in the home.
- A resident manager lives in the home and is responsible for the care and services of each resident at all times.
- The provider, entity representative, or resident manager does not live in the home but the home has 24-hour staffing coverage, and a staff person who can make needed decisions is always present in the home.

The normal staffing levels for the home are:

- Registered nurse, days and times: Nurse Delegator
- Licensed practical nurse, days and times: Home Doctor
- Certified nursing assistant or long term care workers, days and times: 24/7
- Awake staff at night
- Other:

Medicaid

The home must provide each resident with a list of activities customarily available in the home or arranged for by the home (WAC 388-76-10530).

The home provides the following:

Music, bingo, games, gardening, walks, holiday events, celebration of all birthdays, movie night, ladies day. Traveling library also brings books, movies, and audio tapes to preference.
