Personal Care

1. EATING

If needed, the home may provide assistance with eating as follows:

Caregiver assist feeding, puree or blended food, diabetic meals,

2. TOILETING

If needed, the home may provide assistance with toileting as follows:

Managing toileting as need it; incontinence care available

3. WALKING

If needed, the home may provide assistance with walking as follows:

Use of cones, walkers, care giver assistance in walking resident.

4. TRANSFERRING

If needed, the home may provide assistance with transferring as follows:

One or two person transfer assistance, wheel-chair or hoist-lift.

5. POSITIONING

If needed, the home may provide assistance with positioning as follows:

One or two care giver assistance for repositioning, comfort assurance.

6. PERSONAL HYGIENE

If needed, the home may provide assistance with personal hygiene as follows:

Daily cleaning, brushing hair, teeth, shower, washing need it parts

7. DRESSING

Assisting in dressing daily, laundry daily - clean clothes provided.
