<p>2. TOILETING If needed, the home may provide assistance with toileting as follows: We provide toileting assistance from cuing and monitoring to total assistance</p>
<p>3. WALKING If needed, the home may provide assistance with walking as follows: We provide walking assistance from cuing and monitoring to a one or two person assist</p>

(WAC 388-76-10040)

- The provider lives in the home.
- A resident manager lives in the home and is responsible for the care and services of each resident at all times.
- The provider, entity representative, or resident manager does not live in the home but the home has 24-hour staffing coverage, and a staff person who can make needed decisions is always present in the home.

The normal staffing levels for the home are:

- Registered nurse, days and times: As needed
