Personal Care

“Personal care services” means both physical assistance and/or prompting and supervising the performance of direct personal care tasks as determined by the resident’s needs, and does not include assistance with tasks performed by a licensed health professional. (WAC 388-76-10000)

1. EATING

If needed, the home may provide assistance with eating as follows:

From cueing & monitoring to total assistance. If needed, therapeutic diets, diabetic diets, mechanical altered diets and adaptive equipment are provided.

2. TOILETING

If needed, the home may provide assistance with toileting as follows:

From cueing & monitoring to total assistance. If needed, we provide catheter and ostomy care.

3. WALKING

If needed, the home may provide assistance with walking as follows:

From cueing & monitoring to one person stand-by assistance. We are unable to accommodate motorized scooters.

4. TRANSFERRING

If needed, the home may provide assistance with transferring as follows:

From cueing & monitoring to one person lift assist. We are unable to accommodate hoier lifts.

5. POSITIONING

If needed, the home may provide assistance with positioning as follows:

From cueing & monitoring to total assistance with turning and repositioning at regular intervals

6. PERSONAL HYGIENE

If needed, the home may provide assistance with personal hygiene as follows:

From cueing & monitoring to total assistance by one person

7. DRESSING

If needed, the home may provide assistance with dressing as follows:

From cueing & monitoring to total assistance by one person

8. BATHING

If needed, the home may provide assistance with bathing as follows:

From cueing & monitoring to total assistance by one person. The home has wheel-in shower

9. ADDITIONAL COMMENTS REGARDING PERSONAL CARE

Medication Services

If the home admits residents who need medication assistance or medication administration services by a legally authorized person, the home must have systems in place to ensure the services provided meet the medication needs of each resident and meet all laws and rules relating to medications. (WAC 388-76-10430)

The type and amount of medication assistance provided by the home is:

Medication assistance is provided according to resident's need stated on the assesement. Medication administration is provided through nurse delegation

We provide health monitoring, daily management of pain, end of life comfort measures

Skilled Nursing Services and Nurse Delegation

If the home identifies that a resident has a need for nursing care and the home is not able to provide the care per chapter 18.79 RCW, the home must contract with a nurse currently licensed in the state of Washington to provide the nursing care and service, or hire or contract with a nurse to provide nurse delegation. (WAC 388-76-10405)

The home provides the following skilled nursing services:

Administration of medication via oral, nasal, topical, rectal, vaginal, inhalation therapy, eye drops and injection (insulin) route. Blood glucose monitoring, gastrostomy feedings, INR checks, dressing changes, ostomy care, oxygen.

The home has the ability to provide the following skilled nursing services by delegation:

Delegation services are offered at no additional charge by RN provider.

Staffing

The home's provider or entity representative must live in the home, or employ or have a contract with a resident manager who lives in the home and is responsible for the care and services of each resident at all times. The provider, entity representative, or resident manager is exempt from the requirement to live in the home if the home has 24-hour staffing coverage and a staff person who can make needed decisions is always present in the home. (WAC 388-76-10040)

- The provider lives in the home.
- A resident manager lives in the home and is responsible for the care and services of each resident at all times.
- The provider, entity representative, or resident manager does not live in the home but the home has 24-hour staffing coverage, and a staff person who can make needed decisions is always present in the home.

The normal staffing levels for the home are:

- Registered nurse, days and times: **RN provider lives on site; days and times in AFH vary.**

Medicaid

The home must provide each resident with a list of activities customarily available in the home or arranged for by the home (WAC 388-76-10530).

The home provides the following:

Exercise program, library delivery, music, arts & crafts, newspaper, puzzles, bingo, movies, magazines.
