COOK ALL MEALS, PROVIDE SET UP, FEED CLIENT IF NEEDED. WIPE MOUTH, HELP WITH DRINKING LIQUID WITH STRAW OR NO STRAW.

2. TOILETING

If needed, the home may provide assistance with toileting as follows:

PERI CARE IN BED. CLEAN WITH SOAP AND WATER, USE WIPES, TAKE CLIENT TO BATHROOM. WIPE BOTTOM. USE ADULT BRIEFS, USE CREAM IF NEEDED AND PRESCRIBED.

3. WALKING

If needed, the home may provide assistance with walking as follows:

HOLD ARM / HAND WHILE WALKING, BRING WALKER OR CANE TO CLIENT. LEAVE HALLWAY LIGHTS ON. KEEP WALK WAYS CLEAR.

4. TRANSFERRING

If needed, the home may provide assistance with transferring as follows:

USE GAIT BELT OR HOIST IF NEEDED OR PRESCRIBED. TRANSFER SLOWLY AND STEADILY.

5. POSITIONING

If needed, the home may provide assistance with positioning as follows:

REPOSITION EVERY 2 HOURS IN BED AND IN WHEEL CHAIR, RANGE OF MOTION IF PRESCRIBED. ANYTHING ELSE THAT PHYSICAL THERAPY ASSIGNS.

6. PERSONAL HYGIENE

If needed, the home may provide assistance with personal hygiene as follows:

WASH HANDS AND FACE, BRUSH TEETH, COMB HAIR, APPLY LOTION AND CREAM, SHAVE FACIAL HAIR.

7. DRESSING

If needed, the home may provide assistance with dressing as follows:

PICK OUT WEATHER APPROPRIATE CLOTHING, TIE LACES, BUTTON CLOTHING, DRESS LOWER AND UPPER EXTREMITIES. WASH ALL LAUNDRY.

TRANSFER CLIENT INTO SHOWER CHAIR, CHECK WATER TEMPERATURE, WASH HAIR, BODY AND FACE, DRY CLIENT WITH TOWEL, PROTECT EYES WITH RAG FROM SOAP.

Medication Services
