Personal Care

If needed, the home may provide assistance with eating as follows:

2. TOILETING

If needed, the home may provide assistance with toileting as follows:

Assistance ranges from Cuing, Monitor and Set up, Partial to Total assistance.

3. WALKING

If needed, the home may provide assistance with walking as follows:

Assistance ranges from Cuing, Monitor and Set up, Partial to Total assistance.

4. TRANSFERRING

If needed, the home may provide assistance with transferring as follows:

Assistance ranges from Cuing, Monitor and Set up, Partial to Total assistance.

5. POSITIONING

If needed, the home may provide assistance with positioning as follows:

Assistance ranges from Cuing, Monitor and Set up, Partial to Total assistance.

6. PERSONAL HYGIENE

If needed, the home may provide assistance with personal hygiene as follows:

Assistance ranges from Cuing, Monitor and Set up, Partial to Total assistance.

7. DRESSING

If needed, the home may provide assistance with dressing as follows:

Medication Services

Skilled Nursing Services and Nurse Delegation

(WAC 388-76-10040)

- A resident manager lives in the home and is responsible for the care and services of each resident at all times.
- The provider, entity representative, or resident manager does not live in the home but the home has 24-hour staffing coverage, and a staff person who can make needed decisions is always present in the home.
