### Personal Care

“Personal care services” means both physical assistance and/or prompting and supervising the performance of direct personal care tasks as determined by the resident’s needs, and does not include assistance with tasks performed by a licensed health professional. (WAC 388-76-10000)

1. EATING

If needed, the home may provide assistance with eating as follows:

**Tendercare will supervise/ assist resident with feeding,serve,cut up food if there is a need for from regular to puree diet.**

2. TOILETING

If needed, the home may provide assistance with toileting as follows:

**Tendercare will supervise/assist resident with toileting which include pericare changing and assist with put on and take off incontinence needs**

3. WALKING

If needed, the home may provide assistance with walking as follows:

**Tendercare will assist /cue resident with walking using assistive device such as walker,wheel chair. from room to common area and around the facility or as directed by a qualifief Physical therapist order.**

4. TRANSFERRING

If needed, the home may provide assistance with transferring as follows:

**Tendercare will and can provide transfer assistance to resident from bed to chair and sitting to standing and lying and as needed.**

5. POSITIONING

If needed, the home may provide assistance with positioning as follows:

**Tendecare will and can assist resident with position changes while in bed side to side and as needed.**

6. PERSONAL HYGIENE

If needed, the home may provide assistance with personal hygiene as follows:

**Tendercare will and can assist resident with pericare,brush hair,brush teeth,clean dentures**

7. DRESSING

If needed, the home may provide assistance with dressing as follows:

**Tendercare will and can assist resident with dressing,changing undergarment, put/take off socks.**

8. BATHING

If needed, the home may provide assistance with bathing as follows:

**Tendercare will and can assist and cue resident with bathing daily,2 x/wk or as needed.**

9. ADDITIONAL COMMENTS REGARDING PERSONAL CARE

**Bedbath can also be done if requested.**

**Medication Services**

If the home admits residents who need medication assistance or medication administration services by a legally authorized person, the home must have systems in place to ensure the services provided meet the medication needs of each resident and meet all laws and rules relating to medications. (WAC 388-76-10430)

The type and amount of medication assistance provided by the home is:

**Tendercare can and assist resident with medication administration,will order,store and prepare medication for resident.**

**Tendercare will assist resident with mixing medication in applesauce can assist to put medication in resident mouth under the training of nurse delegation**

**Skilled Nursing Services and Nurse Delegation**

If the home identifies that a resident has a need for nursing care and the home is not able to provide the care per chapter 18.79 RCW, the home must contract with a nurse currently licensed in the state of Washington to provide the nursing care and service, or hire or contract with a nurse to provide nurse delegation. (WAC 388-76-10405)

**Tendercare can assist resident with glucose monitoring under the training of nurse delegation.**

**Staffing**

The home's provider or entity representative must live in the home, or employ or have a contract with a resident manager who lives in the home and is responsible for the care and services of each resident at all times. The provider, entity representative, or resident manager is exempt from the requirement to live in the home if the home has 24-hour staffing coverage and a staff person who can make needed decisions is always present in the home. (WAC 388-76-10040)

- The provider lives in the home.
- A resident manager lives in the home and is responsible for the care and services of each resident at all times.
- The provider, entity representative, or resident manager does not live in the home but the home has 24-hour staffing coverage, and a staff person who can make needed decisions is always present in the home.

The normal staffing levels for the home are:
