## Personal Care

“Personal care services” means both physical assistance and/or prompting and supervising the performance of direct personal care tasks as determined by the resident’s needs, and does not include assistance with tasks performed by a licensed health professional. (WAC 388-76-10000)

### 1. EATING

If needed, the home may provide assistance with eating as follows:

**cooking and monitoring, feeding, all the way to total assistance.**

### 2. TOILETING

If needed, the home may provide assistance with toileting as follows:

**monitoring, pericare, transfers to commode, etc.**

### 3. WALKING

If needed, the home may provide assistance with walking as follows:

**guidance to total assistance**

### 4. TRANSFERRING

If needed, the home may provide assistance with transferring as follows:

**transferring to/from wheelchair, bathtub, car, etc.**

### 5. POSITIONING

If needed, the home may provide assistance with positioning as follows:

**repositioning in bed, turning over every 2 hours**

### 6. PERSONAL HYGIENE

If needed, the home may provide assistance with personal hygiene as follows:

**cooking or monitoring resident while brushing teeth, washing hands/face, fixing hair, etc. to total assistance**

### 7. DRESSING

If needed, the home may provide assistance with dressing as follows:

**cooking and set-up to total assistance**

### 8. BATHING

If needed, the home may provide assistance with bathing as follows:

**cooking, monitoring and/or set-up to total assistance**

### 9. ADDITIONAL COMMENTS REGARDING PERSONAL CARE

**We provide haircuts, and nail maintenance as well as facial care/shaving for residents.**

## Medication Services

If the home admits residents who need medication assistance or medication administration services by a legally authorized person, the home must have systems in place to ensure the services provided meet the medication needs of each resident and meet all laws and rules relating to medications. The provider, entity representative, or resident manager is exempt from the requirement to live in the home if the home has 24-hour staffing coverage and a staff person who can make needed decisions is always present in the home. (WAC 388-76-10040)

- A resident manager lives in the home and is responsible for the care and services of each resident at all times.
- The provider, entity representative, or resident manager does not live in the home but the home has 24-hour staffing coverage, and a staff person who can make needed decisions is always present in the home.
