Personal Care

“Personal care services” means both physical assistance and/or prompting and supervising the performance of direct personal care tasks as determined by the resident’s needs, and does not include assistance with tasks performed by a licensed health professional. (WAC 388-76-10000)

1. EATING

2. TOILETING

If needed, the home may provide assistance with toileting as follows:

3. WALKING

If needed, the home may provide assistance with walking as follows:

All assistance needed - wheelchair, walkers, personal assistance

4. TRANSFERRING

If needed, the home may provide assistance with transferring as follows:

Any needed - lifting using two caregivers, hoier lifts, etc

5. POSITIONING

If needed, the home may provide assistance with positioning as follows:

Any that is ordered by our residents' doctor or family and delegated by our nurse delegator.

6. PERSONAL HYGIENE

If needed, the home may provide assistance with personal hygiene as follows:

7. DRESSING

If needed, the home may provide assistance with dressing as follows:

8. BATHING

If needed, the home may provide assistance with bathing as follows:

All needed. We have a large walk in shower.

Medication Services

If the home admits residents who need medication assistance or medication administration services by a legally authorized person, the home must have systems in place to ensure the services provided meet the medication needs of each resident and meet all laws and rules relating to medications. - The provider, entity representative, or resident manager does not live in the home but the home has 24-hour staffing coverage, and a staff person who can make needed decisions is always present in the home.
