Personal Care

"Personal care services" means both physical assistance and/or prompting and supervising the performance of direct personal care tasks as determined by the resident's needs, and does not include assistance with tasks performed by a licensed health professional. (WAC 388-76-10000)

1. EATING

If needed, the home may provide assistance with eating as follows:

Help with feeding Residents with all meals

2. TOILETING

If needed, the home may provide assistance with toileting as follows:

Help with toileting if Resident unable.

3. WALKING

If needed, the home may provide assistance with walking as follows:

Help with walkers and/or wheelchair use if walking is unable

4. TRANSFERRING

If needed, the home may provide assistance with transferring as follows:

Transferring help provided if client can bear some weight.

5. POSITIONING

If needed, the home may provide assistance with positioning as follows:

Pillows used for positioning. Hospital beds used for all

6. PERSONAL HYGIENE

Residents to help with positioning or elevating feet.

If needed, the home may provide assistance with personal hygiene as follows:

Help with providing all ADLs if unable

7. DRESSING

If needed, the home may provide assistance with dressing as follows:

Caregivers will help with all dressing needs, including stockings

8. BATHING

If needed, the home may provide assistance with bathing as follows:

Caregivers will provide complete bathing care in showers

9. ADDITIONAL COMMENTS REGARDING PERSONAL CARE

Medication Services

Staffing

The home's provider or entity representative must live in the home, or employ or have a contract with a resident manager who lives in the home and is responsible for the care and services of each resident at all times. The provider, entity representative, or resident manager is exempt from the requirement to live in the home if the home has 24-hour staffing coverage and a staff person who can make needed decisions is always present in the home. (WAC 388-76-10040)

- The provider lives in the home. *Both provider and manager live in the house*
- A resident manager lives in the home and is responsible for the care and services of each resident at all times.
- The provider, entity representative, or resident manager does not live in the home but the home has 24-hour staffing coverage, and a staff person who can make needed decisions is always present in the home.

The normal staffing levels for the home are:

- Registered nurse, days and times: *as needed by delegating tasks*
- Licensed practical nurse, days and times: *as needed providing foot care*
- Certified nursing assistant or long term care workers, days and times: *1-2 dayshift and 1-evening shift.*
- Awake staff at night

Medicaid
