<p>If needed, the home may provide assistance with eating as follows:  <b>WRW can provided one on one staff or nursing support for tube feeders.</b></p>
<p>2. TOILETING          If needed, the home may provide assistance with toileting as follows:  <b>WRW can develop bowel programs, depends, digitals stem, etc...,</b></p>
<p>3. WALKING          If needed, the home may provide assistance with walking as follows:  <b>WRW will create mobility program with the help of OT, PT and Physicians.</b></p>
<p>4. TRANSFERRING          If needed, the home may provide assistance with transferring as follows:  <b>WRW will follow the Physician or PT's orders. Staff will us adaptive devices to ensure safety of residents and staff.</b></p>
<p>5. POSITIONING          If needed, the home may provide assistance with positioning as follows:  <b>As needed per Physician orders to reduce pressure ulcers/skin breakdown.</b></p>
<p>6. PERSONAL HYGIENE          If needed, the home may provide assistance with personal hygiene as follows:  <b>WRW will provide any level of assistance that is needed.</b></p>
<p>7. DRESSING          If needed, the home may provide assistance with dressing as follows:  <b>WRW will provide what ever level of care is needed.</b></p>
<p>8. BATHING          If needed, the home may provide assistance with bathing as follows:  <b>WRW will provide scheduled as well as needed bed bath and showers.</b></p>

<p><b>Medication Services</b></p>
<p>If the home admits residents who need medication assistance or medication administration services by a legally authorized person, the home must have systems in place to ensure the services provided meet the medication needs of each resident and meet all laws and rules relating to medications.
