Personal Care

“Personal care services” means both physical assistance and/or prompting and supervising the performance of direct personal care tasks as determined by the resident’s needs, and does not include assistance with tasks performed by a licensed health professional. (WAC 388-76-10000)

1. EATING

If needed, the home may provide assistance with eating as follows:

Assistance with eating is provided as needed and required as stated in the assesment.

2. TOILETING

If needed, the home may provide assistance with toileting as follows:

Assistance with toileting is provided as needed and required as stated in the assesment.

3. WALKING

If needed, the home may provide assistance with walking as follows:

Assistance with walking is provided as needed and required as stated in the assesment.

4. TRANSFERRING

If needed, the home may provide assistance with transferring as follows:

Assistance with transferring is provided as needed and required as per the family/ guardian.

5. POSITIONING

If needed, the home may provide assistance with positioning as follows:

Assistance with positioning is provided as needed and required as stated in the assesment.

6. PERSONAL HYGIENE

If needed, the home may provide assistance with personal hygiene as follows:

Assistance with personal hygiene is provided as needed and required as stated in the assesment.

7. DRESSING

If needed, the home may provide assistance with dressing as follows:

Assistance with dressing is provided as needed and required as stated in the assesment.

8. BATHING

If needed, the home may provide assistance with bathing as follows:

Assistance with bathing is provided as needed and required as stated in the assesment.

9. ADDITIONAL COMMENTS REGARDING PERSONAL CARE

Medication Services

If the home admits residents who need medication assistance or medication administration services by a legally authorized person, the home must have systems in place to ensure the services provided meet the medication needs of each resident and meet all laws and rules relating to medications. (WAC 388-76-10430)

Skilled Nursing Services and Nurse Delegation

If the home identifies that a resident has a need for nursing care and the home is not able to provide the care per chapter 18.79 RCW, the home must contract with a nurse currently licensed in the state of Washington to provide the nursing care and service, or hire or contract with a nurse to provide nurse delegation. (WAC 388-76-10405)

The home provides the following skilled nursing services:

Nurse delegation comes to the adult care home on a regular basis.

The home has the ability to provide the following skilled nursing services by delegation:

Distribute medication, eye-drops, insulin, take blood pressure. CPR & First Aid services, provide wound care.

The provider, entity representative, or resident manager is exempt from the requirement to live in the home if the home has 24-hour staffing coverage and a staff person who can make needed decisions is always present in the home. (WAC 388-76-10040)

- The provider lives in the home.
- A resident manager lives in the home and is responsible for the care and services of each resident at all times.
- The provider, entity representative, or resident manager does not live in the home but the home has 24-hour staffing coverage, and a staff person who can make needed decisions is always present in the home.
