WAC 388-76-10715 Doors Ability to open. The adult family home must ensure:

(2) Every closet door opens from the inside and outside; and

This requirement was not met as evidenced by:

Based on observation and interview, the adult family home (AFH) failed to ensure closet doors on two of four sampled residents' rooms (Room A and C) had the ability to be opened from the inside when closed. This placed Resident #1, #2 and #3 at risk for potential harm when trapped inside the closet doors.

Findings included...

On 08/01/19 at 11:00 AM during environmental tour with Staff B, Resident Manager, showed Room A's sliding closet doors where Resident #2 and #3, resided did not have the ability to be opened from the inside when the doors were closed. No handles nor knobs were found from the inside of the doors.

On 08/01/19 at 11:10 AM on further observation with Staff B, Room C's sliding closet doors where Resident #1 resided also did not have the ability to be opened from the inside when the doors were closed. No handles nor knobs were found from the inside of the doors.

On 08/01/19 at 11:15 AM during an interview with Staff B he stated, "We did not know it was a requirement that the closet doors should have the ability to be opened from the inside, we will place handles or knobs so they can be opened from the inside."
