Personal Care

“Personal care services” means both physical assistance and/or prompting and supervising the performance of direct personal care tasks as determined by the resident’s needs, and does not include assistance with tasks performed by a licensed health professional. (WAC 388-76-10000)

1. EATING

If needed, the home may provide assistance with eating as follows:

From cueing, monitoring to total assistance

2. TOILETING

If needed, the home may provide assistance with toileting as follows:

From cueing, monitoring to total assistance

3. WALKING

If needed, the home may provide assistance with walking as follows:

From cueing, monitoring to total assistance

4. TRANSFERRING

If needed, the home may provide assistance with transferring as follows:

From cueing, monitoring to total assistance (one or two person transfer/hoyer lift transfer)

5. POSITIONING

If needed, the home may provide assistance with positioning as follows:

From cueing, monitoring to total assistance

6. PERSONAL HYGIENE

If needed, the home may provide assistance with personal hygiene as follows:

From cueing, set up to total assistance

7. DRESSING

If needed, the home may provide assistance with dressing as follows:

Medication Services

Medication management is provided and consist in: keeping meds in locked storage, record meds in resident's log, inform doctors and pharmacists about side effects and ask for refills

Skilled Nursing Services and Nurse Delegation

If the home identifies that a resident has a need for nursing care and the home is not able to provide the care per chapter 18.79 RCW, the home must contract with a nurse currently licensed in the state of Washington to provide the nursing care and service, or hire or contract with a nurse to provide nurse delegation. (WAC 388-76-10405)

(WAC 388-76-10040)

- A resident manager lives in the home and is responsible for the care and services of each resident at all times.
- The provider, entity representative, or resident manager does not live in the home but the home has 24-hour staffing coverage, and a staff person who can make needed decisions is always present in the home.
