Personal Care

If needed, the home may provide assistance with toileting as follows:

Assistance by cueing and monitoring total assistance w/ peri care / toileting.

3. WALKING

If needed, the home may provide assistance with walking as follows:

1:1 or 2:1 Assist w/ gait belt, wheelchair or walker

4. TRANSFERRING

If needed, the home may provide assistance with transferring as follows:

1:1 or 2:1 transfer, pivot transfer

5. POSITIONING

If needed, the home may provide assistance with positioning as follows:

Schedule of turning every 2 hours and as needed

6. PERSONAL HYGIENE

If needed, the home may provide assistance with personal hygiene as follows:

Providing assistance to total care.

7. DRESSING

If needed, the home may provide assistance with dressing as follows:

Providing assistance to total care.

8. BATHING

If needed, the home may provide assistance with bathing as follows:

Medication Services

(WAC 388-76-10040)

- The provider, entity representative, or resident manager does not live in the home but the home has 24-hour staffing coverage, and a staff person who can make needed decisions is always present in the home.
