Personal Care

Any transfers including Hoyer lift.

5. POSITIONING

If needed, the home may provide assistance with positioning as follows:

Any positioning or repositioning as needed.

If needed, the home may provide assistance with personal hygiene as follows:

Brushing teeth, combing hair, trimming nails.

7. DRESSING
