Personal Care

"Personal care services" means both physical assistance and/or prompting and supervising the performance of direct personal care tasks as determined by the resident's needs, and does not include assistance with tasks performed by a licensed health professional. (WAC 388-76-10000)

1. EATING

If needed, the home may provide assistance with eating as follows: *STAFF IS AVAILABLE WHEN RESIDENTS NEED ASST. WITH EATING STAFF ARE IN THE DINING AREA*

2. TOILETING

If needed, the home may provide assistance with toileting as follows: *THE HOME DOES ASST WITH DANIEL AND BLADDER INCONTINENT RESIDENTS ARE TOILET EVERY 2 HOURS AND AS NEEDED.*

3. WALKING

If needed, the home may provide assistance with walking as follows: *RESIDENTS WITH WALKERS WILL BE ASST AND BATHROOM DURING IF NEEDED BY WE OFFER HAND BY ASST.*

4. TRANSFERRING

If needed, the home may provide assistance with transferring as follows: *WE HAVE A GAIT BELT IN THE HOME IF RESIDENTS REQUIRE A NEED TO USE ONE.*

5. POSITIONING

If needed, the home may provide assistance with positioning as follows: *2 HOW POSITIONING IS AVAILABLE FOR RESIDENTS THAT ARE NOT ABLE TO DO THEMSELVES TO PREVENT PRESSURE SORES*

6. PERSONAL HYGIENE

If needed, the home may provide assistance with personal hygiene as follows: *IF NEEDED HELP WITH DAILY ADL'S SUCH AS BRUSHING HAIR, TEETH, WASHING FACE*

7. DRESSING

Medication Services

If the home admits residents who need medication assistance or medication administration services by a legally authorized person, the home must have systems in place to ensure the services provided meet the medication needs of each resident and meet all laws and rules relating to medications. (WAC 388-76-10430)

Skilled Nursing Services and Nurse Delegation

If the home identifies that a resident has a need for nursing care and the home is not able to provide the care per chapter 18.79 RCW, the home must contract with a nurse currently licensed in the state of Washington to provide the nursing care and service, or hire or contract with a nurse to provide nurse delegation. (WAC 388-76-10405)

- The provider, entity representative, or resident manager does not live in the home but the home has 24-hour staffing coverage, and a staff person who can make needed decisions is always present in the home.
