### Personal Care

“Personal care services” means both physical assistance and/or prompting and supervising the performance of direct personal care tasks as determined by the resident’s needs, and does not include assistance with tasks performed by a licensed health professional. (WAC 388-76-10000)

1. EATING

If needed, the home may provide assistance with eating as follows:

**Cooking meals that fit diet needs of residents, cutting up food, feeding.**

2. TOILETING

If needed, the home may provide assistance with toileting as follows:

**Incontinence care, peri care, transfer to toilet. nighttime bedside commode. catheter care and irrigation**

3. WALKING

If needed, the home may provide assistance with walking as follows:

**Gait-belt ambulation assist, stand by assist.**

4. TRANSFERRING

If needed, the home may provide assistance with transferring as follows:

**Able to transfer with stand by assist, gait belt, or specialized lifts such as hoyer lift.**

5. POSITIONING

If needed, the home may provide assistance with positioning as follows:

**Positioning every 2 hours**

6. PERSONAL HYGIENE

If needed, the home may provide assistance with personal hygiene as follows:

**Able to provide assistance or fully provide hygiene care for resident.**

7. DRESSING

If needed, the home may provide assistance with dressing as follows:

**Able to fully dress client with little or no assistance from client.**

8. BATHING

If needed, the home may provide assistance with bathing as follows:

**Able to fully bathe resident with little or no assistance from the resident.**

**Medication Services**

### Staffing

(WAC 388-76-10040)

- A resident manager lives in the home and is responsible for the care and services of each resident at all times.
- The provider, entity representative, or resident manager does not live in the home but the home has 24-hour staffing coverage, and a staff person who can make needed decisions is always present in the home.
