Personal Care

1. EATING

If needed, the home may provide assistance with eating as follows:

Cueing and monitoring to total assistance.

2. TOILETING

If needed, the home may provide assistance with toileting as follows:

Cueing and monitoring to total assistance.

3. WALKING

If needed, the home may provide assistance with walking as follows:

Cueing and monitoring to two person assist.

4. TRANSFERRING

If needed, the home may provide assistance with transferring as follows:

Cueing and monitoring to one or two person assist, to hooyer lift.

5. POSITIONING

If needed, the home may provide assistance with positioning as follows:

Cueing and monitoring to one or two person assist. As directed by care plan and Physician/RN.

6. PERSONAL HYGIENE

If needed, the home may provide assistance with personal hygiene as follows:

Provide assistance to total assistance.

7. DRESSING

If needed, the home may provide assistance with dressing as follows:

Cueing and setup to total assistance.

8. BATHING

If needed, the home may provide assistance with bathing as follows:

Cueing and setup to total assistance.

9. ADDITIONAL COMMENTS REGARDING PERSONAL CARE

Bailey Manor 2 has 5 bathrooms, tehre are 2 bathrooms shared by 2 residents each, and 2 bedrooms with private baths. There is 1 main bathroom with a roll in shower

Medication Services

All caregivers are delegated by an RN. Additionally, our RN monitors Medication Records and processes regularly

Skilled Nursing Services and Nurse Delegation

If the home identifies that a resident has a need for nursing care and the home is not able to provide the care per chapter 18.79 RCW, the home must contract with a nurse currently licensed in the state of Washington to provide the nursing care and service, or hire or contract with a nurse to provide nurse delegation. (WAC 388-76-10405)

The home provides the following skilled nursing services:

Bailey Manor 2 contracts with a Licensed RN to monitor our processes with giving care and administering medicatons. She is available for consult and gives advice when necessary.

The home has the ability to provide the following skilled nursing services by delegation:

Bailey Manor contracts with a Licensed RN to provide Nurse Delegation and medication monitoring.

Staffing

The home’s provider or entity representative must live in the home, or employ or have a contract with a resident manager who lives in the home and is responsible for the care and services of each resident at all times. The provider, entity representative, or resident manager is exempt from the requirement to live in the home if the home has 24-hour staffing coverage and a staff person who can make needed decisions is always present in the home. (WAC 388-76-10040)

- The provider lives in the home.
- A resident manager lives in the home and is responsible for the care and services of each resident at all times.
- The provider, entity representative, or resident manager does not live in the home but the home has 24-hour staffing coverage, and a staff person who can make needed decisions is always present in the home.

The normal staffing levels for the home are:

- Registered nurse, days and times: As needed
- Licensed practical nurse, days and times: _____
- Certified nursing assistant or long term care workers, days and times: CNA's work 24/7
- Awake staff at night

ADDITIONAL COMMENTS REGARDING STAFFING

Caregivers work 24/7 and are awake. There is a shift overlap at each change in shifts. Additionally we add staff when needed and porivders are also in and out to help

Cultural or Language Access

We bake cookies, watch tv, have movie nights with popcorn, do crafts, puzzles, plan deck plants, fold laundry, and go out for lunch. Activities are catered to each resident.
