Personal Care

“Personal care services” means both physical assistance and/or prompting and supervising the performance of direct personal care tasks as determined by the resident’s needs, and does not include assistance with tasks performed by a licensed health professional. (WAC 388-76-10000)

1. EATING

If needed, the home may provide assistance with eating as follows:

When deemed appropriate by the provider, the AFH may provide the following:

- * **Supervising and cueing residents who are at risk for choking/aspiration**
- * **Altering texture of food . IE: Cutting into bite size pieces, chopping and/or pureeing of solid foods**
- * **Feeding residents as indicated**

2. TOILETING

If needed, the home may provide assistance with toileting as follows:

When deemed appropriate by the provider, the AFH may provide the following:

- * **Reminding residents to visit the bathroom regularly**
- * **Supervise or provide stand by assistance while toileting**
- * **Assistance with use of bed side commode, bed pan or urinal**
- * **Changing of briefs/pads and incontinence care as needed**

3. WALKING

If needed, the home may provide assistance with walking as follows:

When deemed appropriate by the provider, the AFH may provide the following:

- * **Reminding resident to use assistive devices**
- * **Cueing residents on correct of use of all medical devices**
- * **Standby or contact assistance with or without the use of gate belt during walking**
- * **Encouraging regular exercise**

4. TRANSFERRING

If needed, the home may provide assistance with transferring as follows:

When deemed appropriate by the provider, the AFH may provide the following:

- * **Supervision or standby assist with transfers**
- * **One person assistance with transfers**
- * **Provide Hoyer/Stand-up lift transfers as indicated**

5. POSITIONING

If needed, the home may provide assistance with positioning as follows:

When deemed appropriate by the provider, the AFH may provide the following:

- * **Cueing and reminding residents to change position**
- * **One person assistance with changing position or turning while in the bed or chair**
- * **Provide turning on a regular schedule for residents at high risk for skin breakdown / bedsores.**

6. PERSONAL HYGIENE

If needed, the home may provide assistance with personal hygiene as follows:

When deemed appropriate by the provider, the AFH may provide the following:

- * Assistance with oral care
- * Assistance with shaving and hair styling
- * Assistance with showers weekly or as needed
- * Bed bath if resident is unable to use shower
- * Application of deodorant, lotions and makeup
- * Assistance with nail care

7. DRESSING

If needed, the home may provide assistance with dressing as follows:

When deemed appropriate by the provider, the AFH may provide the following:

- * Supervision and standby assistance during dressing
- * Provide total assistance with dressing

8. BATHING

If needed, the home may provide assistance with bathing as follows:

When deemed appropriate by the provider, the AFH may provide the following:

- * Supervision during showers
- * Cueing residents during showers
- * Provide total assistance during showers
- * Skin assessment during each shower

9. ADDITIONAL COMMENTS REGARDING PERSONAL CARE

Staff at Factoria AFH, Inc. encourage residents to be as independent as possible.

Medication Services

If the home admits residents who need medication assistance or medication administration services by a legally authorized person, the home must have systems in place to ensure the services provided meet the medication needs of each resident and meet all laws and rules relating to medications. (WAC 388-76-10430)

The type and amount of medication assistance provided by the home is:

When deemed appropriate by the provider, the AFH may provide the following:

- * Reminding residents to take their medications on time
- * Assist residents with administration of oral medications
- * Total assistance with medication administration

ADDITIONAL COMMENTS REGARDING MEDICATION SERVICES

Staff at Factoria AFH, Inc. have been trained to be delegated in various tasks.

Skilled Nursing Services and Nurse Delegation

If the home identifies that a resident has a need for nursing care and the home is not able to provide the care per chapter 18.79 RCW, the home must contract with a nurse currently licensed in the state of Washington to provide the nursing care and service, or hire or contract with a nurse to provide nurse delegation. (WAC 388-76-10405)

The home provides the following skilled nursing services:

When deemed appropriate by the provider, the AFH may contract with a RN delegator for nurse delegation and resident assessments. The costs associated with nurse delegation and assessments are the responsibility of resident. When deemed appropriate by the provider, the AFH may provide care to a more clinically complex resident that might require things like wound care, end of life care or diabetic

management.

The home has the ability to provide the following skilled nursing services by delegation:

When deemed appropriate by the provider, the AFH may have delegation put into place to include medication assistance and/or administration of various medications. The cost of these services would be the responsibility of the resident.

ADDITIONAL COMMENTS REGARDING SKILLED NURSING SERVICE AND NURSING DELEGATION

The provider will ensure there is appropriate staffing in the home.

Specialty Care Designations

We have completed DSHS approved training for the following specialty care designations:

- Developmental disabilities
- Mental illness
- Dementia

ADDITIONAL COMMENTS REGARDING SPECIALTY CARE DESIGNATIONS

When deemed appropriate by the provider, the AFH may provide special care and attention to clients with a diagnosis related to mental illness and/or dementia.

Staffing

The home's provider or entity representative must live in the home, or employ or have a contract with a resident manager who lives in the home and is responsible for the care and services of each resident at all times. The provider, entity representative, or resident manager is exempt from the requirement to live in the home if the home has 24-hour staffing coverage and a staff person who can make needed decisions is always present in the home. (WAC 388-76-10040)

- The provider lives in the home.
- A resident manager lives in the home and is responsible for the care and services of each resident at all times.
- The provider, entity representative, or resident manager does not live in the home but the home has 24-hour staffing coverage, and a staff person who can make needed decisions is always present in the home.

The normal staffing levels for the home are:

- Registered nurse, days and times: As needed
- Licensed practical nurse, days and times: _____
- Certified nursing assistant or long term care workers, days and times: 24 hours/7days a week
- Awake staff at night
- Other: **When deemed appropriate by the provider, the AFH may have awake staff.**

ADDITIONAL COMMENTS REGARDING STAFFING

Staff is based on the needs of our residents. Our staff has received all required WA state training.

Cultural or Language Access

The home must serve meals that accommodate cultural and ethnic backgrounds (388-76-10415) and provide informational materials in a language understood by residents and prospective residents (Chapter 388-76 various sections)

The home is particularly focused on residents with the following background and/or languages:

English is the primary language spoken in Factoria AFH, Inc.. Sensitivity and respect of our resident's ethnicity, culture beliefs and practices is important to our staff. When deemed appropriate by the provider, the AFH may assist with specific requests surrounding ethnic requests.

ADDITIONAL COMMENTS REGARDING CULTURAL OR LANGUAGE ACCESS

The home respects all cultural or religious preferences.

Medicaid

The home must fully disclose the home's policy on accepting Medicaid payments. The policy must clearly state the circumstances under which the home provides care for Medicaid eligible residents and for residents who become eligible for Medicaid after admission. (WAC 388-76-10522)

The home is a private pay facility and does not accept Medicaid payments.

The home will accept Medicaid payments under the following conditions:

This home will accept Medicaid payments after being private pay for 24 months. A 90 days notice is required prior to a private pay resident converting to Medicaid.

ADDITIONAL COMMENTS REGARDING MEDICAID

Factoria AFH Inc. has a Medicaid policy that is disclosed to residents and families prior to admission.

Activities

The home must provide each resident with a list of activities customarily available in the home or arranged for by the home (WAC 388-76-10530).

The home provides the following:

The provider will offer appropriate activities and consider resident's preferences. I.E: exercise, walking, bingo, watching classic movies and shows on TV, ball tossing, piano music, puzzles, books, daily newspaper, beauty day.

ADDITIONAL COMMENTS REGARDING ACTIVITIES

When deemed appropriate by the provider, the AFH may try to provide activities that would match with what a resident has loved doing in the past.
