<p>2. TOILETING</p> <p>If needed, the home may provide assistance with toileting as follows:  <i>Loving Ones provides total assistance with toileting.</i></p>
<p>3. WALKING</p> <p>If needed, the home may provide assistance with walking as follows:  <i>Loving Ones provides total assistance with all mobility.</i></p>
<p>4. TRANSFERRING</p> <p>If needed, the home may provide assistance with transferring as follows:  <i>Loving Ones provides total assistance with transfers.</i></p>
<p>5. POSITIONING</p> <p>If needed, the home may provide assistance with positioning as follows:  <i>Loving Ones provides total assistance with positioning.</i></p>

**Staffing**

The home's provider or entity representative must live in the home, or employ or have a contract with a resident manager who lives in the home and is responsible for the care and services of each resident at all times. The provider, entity representative, or resident manager is exempt from the requirement to live in the home if the home has 24-hour staffing coverage and a staff person who can make needed decisions is always present in the home. (WAC 388-76-10040)

- The provider lives in the home.
- A resident manager lives in the home and is responsible for the care and services of each resident at all times.
- The provider, entity representative, or resident manager does not live in the home but the home has 24-hour staffing coverage, and a staff person who can make needed decisions is always present in the home.

The normal staffing levels for the home are:

- Registered nurse, days and times: once per week, more if needed
- Licensed practical nurse, days and times: \_\_\_\_\_
- Certified nursing assistant or long term care workers, days and times: 24 hrs / 7 days per week
