## Personal Care

If needed, the home may provide assistance with toileting as follows:

**Incontinence care, toileting, transferring, catheter care**

### 3. WALKING

If needed, the home may provide assistance with walking as follows:

**Stand-by assistance, gate belt, wheelchair**

### 4. TRANSFERRING

If needed, the home may provide assistance with transferring as follows:

**One and two person transfers, hoist lift, Sit to Stand**

### 5. POSITIONING

If needed, the home may provide assistance with positioning as follows:

**Positioning as needed**

### 6. PERSONAL HYGIENE

If needed, the home may provide assistance with personal hygiene as follows:

## Medication Services

**Staffing**

- A resident manager lives in the home and is responsible for the care and services of each resident at all times.
- The provider, entity representative, or resident manager does not live in the home but the home has 24-hour staffing coverage, and a staff person who can make needed decisions is always present in the home.

The normal staffing levels for the home are:

- Registered nurse, days and times: **On-staff, on-site as needed**
