Personal Care

"Personal care services" means both physical assistance and/or prompting and supervising the performance of direct personal care tasks as determined by the resident's needs, and does not include assistance with tasks performed by a licensed health professional. (WAC 388-76-10000)

1. EATING

If needed, the home may provide assistance with eating as follows: Caregivers will cut food as necessary, spoon feed, tube feed or bring a tray to individual rooms.

2. TOILETING

If needed, the home may provide assistance with toileting as follows: Will assist w/ transferring, wiping, washing + rinsing + applying barrier cream. Raised toilet seats available. Will fully accommodate incontinent residents as well.

3. WALKING

If needed, the home may provide assistance with walking as follows: Stand by assist, hands on assist, 1 person assist w/ gait belt + walker.

4. TRANSFERRING

If needed, the home may provide assistance with transferring as follows: 1 person assisted transfers.

5. POSITIONING

If needed, the home may provide assistance with positioning as follows: Staff will position residents who are unable to position themselves in bed + /or chair.

6. PERSONAL HYGIENE

If needed, the home may provide assistance with personal hygiene as follows: set up supplies /assist w/ toothbrushing, face washing, denture care, peri-care as needed.

7. DRESSING

If needed, the home may provide assistance with dressing as follows: Staff will assist w/ dressing + undressing as needed.

8. BATHING

If needed, the home may provide assistance with bathing as follows: stand by assist or hands on assist. Will assist w/ washing + shampooing + drying as needed.

9. ADDITIONAL COMMENTS REGARDING PERSONAL CARE

We aspire to meet any + all needs related to personal care.

Medication Services

If the home admits residents who need medication assistance or medication administration services by a legally authorized person, the home must have systems in place to ensure the services provided meet the medication needs of each resident and meet all laws and rules relating to medications. (WAC 388-76-10430)

The type and amount of medication assistance provided by the home is: All medication is managed by staff. If needed (+ delegated) staff will provide assistance w/ eye drops, nose sprays, inhalers, creams, lotions etc. All dispensed meds are recorded in the MAR.

ADDITIONAL COMMENTS REGARDING MEDICATION SERVICES

Skilled Nursing Services and Nurse Delegation

If the home identifies that a resident has a need for nursing care and the home is not able to provide the care per chapter 18.79 RCW, the home must contract with a nurse currently licensed in the state of Washington to provide the nursing care and service, or hire or contract with a nurse to provide nurse delegation. (WAC 388-76-10405)

The home provides the following skilled nursing services: *the owner of the AFH is an RN + will provide skilled nursing services when needed.*

The home has the ability to provide the following skilled nursing services by delegation: *Insulin injections, dressing changes, administering eye drops, nasal sprays, applying creams etc.*

All staff must obtain nurse delegation training + owner will act as the delegating nurse.

ADDITIONAL COMMENTS REGARDING SPECIALTY CARE DESIGNATIONS

At this time all of our residents are cognitive. We are currently not accepting Alzheimer's residents.

Staffing

The home's provider or entity representative must live in the home, or employ or have a contract with a resident manager who lives in the home and is responsible for the care and services of each resident at all times. The provider, entity representative, or resident manager is exempt from the requirement to live in the home if the home has 24-hour staffing coverage and a staff person who can make needed decisions is always present in the home. (WAC 388-76-10040)

- The provider lives in the home.
- A resident manager lives in the home and is responsible for the care and services of each resident at all times.
- The provider, entity representative, or resident manager does not live in the home but the home has 24-hour staffing coverage, and a staff person who can make needed decisions is always present in the home.

The normal staffing levels for the home are:

- Registered nurse, days and times: *weekdays 7-3 + available on call most evenings + weekends*
- Licensed practical nurse, days and times: _____

Medicaid
