Personal Care

“Personal care services” means both physical assistance and/or prompting and supervising the performance of direct personal care tasks as determined by the resident’s needs, and does not include assistance with tasks performed by a licensed health professional. (WAC 388-76-10000)

1. EATING

If needed, the home may provide assistance with eating as follows:

We provide all meals and serve in a home setting dining room or if they prefer in their room. We also assist with cutting up /Blending mechanical soft food and feeding as needed.

2. TOILETING

If needed, the home may provide assistance with toileting as follows:

Assisting each resident to the bathroom or bedside commode if needed in their room . Peri care and changing depends/pads if needed.

3. WALKING

If needed, the home may provide assistance with walking as follows:

All residents are monitored and assisted if needed, contact guard assist/standby assist

4. TRANSFERRING

If needed, the home may provide assistance with transferring as follows:

Help with all residents that require assistance with transferring

5. POSITIONING

If needed, the home may provide assistance with positioning as follows:

We have a schedule in place for all residents requiring help with positioning

6. PERSONAL HYGIENE
