Personal Care

"Personal care services" means both physical assistance and/or prompting and supervising the performance of direct personal care tasks as determined by the resident's needs, and does not include assistance with tasks performed by a licensed health professional. (WAC 388-76-10000)

1. EATING

If needed, the home may provide assistance with eating as follows: *Cuing, Monitoring, Cut food into small pieces and total assistance*

2. TOILETING

If needed, the home may provide assistance with toileting as follows:

Total Assistance. Cuing and Monitoring

3. WALKING

If needed, the home may provide assistance with walking as follows: *One Person assist, Cuing and Monitoring.*

4. TRANSFERRING

If needed, the home may provide assistance with transferring as follows: *Cuing and Monitoring. One person assist*

5. POSITIONING

If needed, the home may provide assistance with positioning as follows: *Cuing and Monitoring. One or two person assist*

6. PERSONAL HYGIENE

If needed, the home may provide assistance with personal hygiene as follows: *Cuing and Set up. Total assistance. Bathing, grooming, Dressing.*

7. DRESSING

If needed, the home may provide assistance with dressing as follows: *Total assistance. Cuing and Monitoring*

8. BATHING

If needed, the home may provide assistance with bathing as follows: *Cuing, Monitoring, Set up to total assistance*
