Personal Care

"Personal care services" means both physical assistance and/or prompting and supervising the performance of direct personal care tasks as determined by the resident's needs, and does not include assistance with tasks performed by a licensed health professional. (WAC 388-76-10000)

1. EATING

If needed, the home may provide assistance with eating as follows:

meals prepared specific to the client (individual preference and/or as ordered); cueing, monitoring, partial or total assistance provided prior, during and after the meal as needed.

2. TOILETING

If needed, the home may provide assistance with toileting as follows:

when appropriate, encourage routine schedules; cueing, stand-by, monitoring, partial or total assisting as needed or ordered.

3. WALKING

If needed, the home may provide assistance with walking as follows:

cueing, stand-by, monitoring, partial or total 1 person assist as needed or ordered.

4. TRANSFERRING

If needed, the home may provide assistance with transferring as follows:

cueing, stand-by, partial or total 1 person assist as needed or ordered.

5. POSITIONING

If needed, the home may provide assistance with positioning as follows:

cueing, monitoring, partial or total 1 person assist as needed or ordered.

6. PERSONAL HYGIENE

If needed, the home may provide assistance with personal hygiene as follows:

set-up, cueing, stand-by, monitoring, partial or total 1 person assist as needed or ordered.

7. DRESSING

If needed, the home may provide assistance with dressing as follows:

set-up, cueing, stand-by, monitoring, partial or total 1 person assist as needed or ordered.

8. BATHING

If needed, the home may provide assistance with bathing as follows:

set-up, cueing, stand-by, monitoring, partial or total 1 person assist as needed or ordered; daily sponge baths or showers and as needed.

9. ADDITIONAL COMMENTS REGARDING PERSONAL CARE

We strive to balance dignity with safety and well being of the resident.

Medication Services

If the home admits residents who need medication assistance or medication administration services by a legally authorized person, the home must have systems in place to ensure the services provided meet the medication needs of each resident and meet all laws and rules relating to medications. (WAC 388-76-10430)

The type and amount of medication assistance provided by the home is:

assisted, administered by caregiver as delegated by RN; self-administered on a case by case basis.

All medications are managed through a LTC and state compliant pharmacy.

Skilled Nursing Services and Nurse Delegation

If the home identifies that a resident has a need for nursing care and the home is not able to provide the care per chapter 18.79 RCW, the home must contract with a nurse currently licensed in the state of Washington to provide the nursing care and service, or hire or contract with a nurse to provide nurse delegation. (WAC 388-76-10405)

The home provides the following skilled nursing services:

RN and ND-RN on-call, hospice care as needed.

The home has the ability to provide the following skilled nursing services by delegation:

all delegated nursing services are available as needed.

Staffing

The home's provider or entity representative must live in the home, or employ or have a contract with a resident manager who lives in the home and is responsible for the care and services of each resident at all times. The provider, entity representative, or resident manager is exempt from the requirement to live in the home if the home has 24-hour staffing coverage and a staff person who can make needed decisions is always present in the home. (WAC 388-76-10040)

- The provider lives in the home.
- A resident manager lives in the home and is responsible for the care and services of each resident at all times.
- The provider, entity representative, or resident manager does not live in the home but the home has 24-hour staffing coverage, and a staff person who can make needed decisions is always present in the home.

The normal staffing levels for the home are:

- Registered nurse, days and times: **On-call**
- Licensed practical nurse, days and times: _____
- Certified nursing assistant or long term care workers, days and times: **24/7; at least 1 per shift.**
- Awake staff at night
- Other: **Home doctor/ARNP available as needed.**

Cultural or Language Access

The home must serve meals that accommodate cultural and ethnic backgrounds (388-76-10415) and provide informational materials in a language understood by residents and prospective residents (Chapter 388-76 various sections)

The home is particularly focused on residents with the following background and/or languages:

English speaking, currently non-smokers. Special diets on a case by case basis.

ADDITIONAL COMMENTS REGARDING CULTURAL OR LANGUAGE ACCESS

We will accommodate Chinese, Dutch, French, German, Greek, Hebrew, Italian, Japanese, Norwegian, Romanian, Russian, Spanish or Swedish speaking residents on a case by case basis.

Medicaid

The home must fully disclose the home's policy on accepting Medicaid payments. The policy must clearly state the circumstances under which the home provides care for Medicaid eligible residents and for residents who become eligible for Medicaid after admission. (WAC 388-76-10522)

The home is a private pay facility and does not accept Medicaid payments.

The home will accept Medicaid payments under the following conditions:

at least 3 years of private pay prior to transferring into the Medicaid program.

ADDITIONAL COMMENTS REGARDING MEDICAID

Activities

The home must provide each resident with a list of activities customarily available in the home or arranged for by the home (WAC 388-76-10530).

The home provides the following:

Board games, card games, gardening, ballon and ball tossing, group and individual exercises, barbequing, major holidays, birthday parties, special family occasions, visits from spiritual ministers, music, nature watching, etc.
