Cueing, supervision, reminders, total assistance including bed bound

3. WALKING

If needed, the home may provide assistance with walking as follows:

Stand by assist, 1 person assist, 2 person assistance

4. TRANSFERRING

If needed, the home may provide assistance with transferring as follows:

Stand by assist, 1 person assist, 2 person assistance, hoyer lift

5. POSITIONING

If needed, the home may provide assistance with positioning as follows:

Cueing, 1 to 2 person assist or repositioning on a routine basis for those bed bound

6. PERSONAL HYGIENE

If needed, the home may provide assistance with personal hygiene as follows:

Set up, cueing, supervision, stand by to total assistance

7. DRESSING

If needed, the home may provide assistance with dressing as follows:

Cueing, supervision, stand by to total assistance

8. BATHING

If needed, the home may provide assistance with bathing as follows:

Cueing, set up, stand by to total assistance including bed bound-
