## Personal Care

"Personal care services" means both physical assistance and/or prompting and supervising the performance of direct personal care tasks as determined by the resident's needs, and does not include assistance with tasks performed by a licensed health professional. (WAC 388-76-10000)

### 1. EATING

If needed, the home may provide assistance with eating as follows:

**Residents prepare their own breakfast & lunch of their choice. Dinner is prepared by Provider. Access to the refrigerator (snacks) is unlimited (which requires working with them on portion-control)! We provide cooking/baking classes for our female residents! They love to learn to bake cookies, make desserts, and sometimes prepare dinner meals (with assistance)!**

### 2. TOILETING

If needed, the home may provide assistance with toileting as follows:

**All our female residents are high-functioning and do not require assistance with toileting. They do take turns on the chore chart cleaning their bathroom toilet as well as cleaning their own private rooms, washing their clothes and folding them, etc. They actually enjoy learning life skills and it builds their self confidence!**

### 3. WALKING

If needed, the home may provide assistance with walking as follows:

**All our female residents are high-functioning and do not require assistance with walking. However, they love to go on walks as a group in the neighborhood, to the park or on the Centennial Trail. We live within walking distance to parks, shopping (the Dollar Tree, Wendy's, McDonalds, Burger King, Jack-in-the-Box, Yokes, Albertsons, Rockwood Clinic-Argonne, Starbucks, etc.)!**

### 4. TRANSFERRING

If needed, the home may provide assistance with transferring as follows:

**All our female residents are high-functioning and do not require assistance with transferring.**

### 5. POSITIONING

If needed, the home may provide assistance with positioning as follows:

**All our female residents are high-functioning and do not require assistance with positioning.**

### 6. PERSONAL HYGIENE

If needed, the home may provide assistance with personal hygiene as follows:

**All our female residents are high-functioning and do not require assistance with hygiene, except for occasional reminders. They love to have "Girl's Night" and do manicures/pedicures, fix each other's hair, do facials and put on makeup!**

### 7. DRESSING

If needed, the home may provide assistance with dressing as follows:

**All our female residents are high-functioning and do not require assistance with dressing, except for occasional buttoning or assistance with weather-appropriate clothing. They do love to have "dress-up" and "girl's pamper night," where they do manicures/pedicures, make popcorn and watch movies!**

### 8. BATHING

If needed, the home may provide assistance with bathing as follows:

**All our female residents are high-functioning and do not require assistance with bathing, except for occasional reminders, or possible assistance with shaving.**

9. ADDITIONAL COMMENTS REGARDING PERSONAL CARE

**Our female residents are active in the community. They use the STA and some use the paratransit (which comes to our front door)**

**Medication Services**

If the home admits residents who need medication assistance or medication administration services by a legally authorized person, the home must have systems in place to ensure the services provided meet the medication needs of each resident and meet all laws and rules relating to medications. (WAC 388-76-10430)

The type and amount of medication assistance provided by the home is:

**All our female residents are high-functioning and only require some medication assistance.**

**Skilled Nursing Services and Nurse Delegation**

If the home identifies that a resident has a need for nursing care and the home is not able to provide the care per chapter 18.79 RCW, the home must contract with a nurse currently licensed in the state of Washington to provide the nursing care and service, or hire or contract with a nurse to provide nurse delegation. (WAC 388-76-10405)

**Our residents do not require skilled nursing services. They are all high-functioning and independent.**

ADDITIONAL COMMENTS REGARDING SPECIALTY CARE DESIGNATIONS

**Our AFH has completed DSHS approved training for all three specialty care designations listed above. However, we only admit high-functioning women with developmental disabilities and minor mental health issues. We do not admit elderly Dementia residents at this location.**

**Staffing**

The home's provider or entity representative must live in the home, or employ or have a contract with a resident manager who lives in the home and is responsible for the care and services of each resident at all times. The provider, entity representative, or resident manager is exempt from the requirement to live in the home if the home has 24-hour staffing coverage and a staff person who can make needed decisions is always present in the home. (WAC 388-76-10040)

- The provider lives in the home.
- A resident manager lives in the home and is responsible for the care and services of each resident at all times.
- The provider, entity representative, or resident manager does not live in the home but the home has 24-hour staffing coverage, and a staff person who can make needed decisions is always present in the home.
