Personal Care

"Personal care services" means both physical assistance and/or prompting and supervising the performance of direct personal care tasks as determined by the resident's needs, and does not include assistance with tasks performed by a licensed health professional. (WAC 388-76-10000)

1. EATING

If needed, the home may provide assistance with eating as follows:

Calorie Controlled, modified texture, less sodium, meatless diets.

2. TOILETING

If needed, the home may provide assistance with toileting as follows:

Will assist as needed with all toileting needs also bed bound residents

3. WALKING

If needed, the home may provide assistance with walking as follows:

Joy AFH will create mobility program with the help of OT, PT and physicians

4. TRANSFERRING

If needed, the home may provide assistance with transferring as follows:

Joy AFH will follow the physician or PT's orders. Staff will use adaptive devices to ensure safety of residents and staff

5. POSITIONING

If needed, the home may provide assistance with positioning as follows:

As needed per physician orders to reduce pressure ulcers/skin breakdown.

Medication Services

Skilled Nursing Services and Nurse Delegation

If the home identifies that a resident has a need for nursing care and the home is not able to provide the care per chapter 18.79 RCW, the home must contract with a nurse currently licensed in the state of Washington to provide the nursing care and service, or hire or contract with a nurse to provide nurse delegation. (WAC 388-76-10405)

The home has the ability to provide the following skilled nursing services by delegation:

Administration of medication, blood sugar monitoring, insulin injection, and oxygen

- The provider, entity representative, or resident manager does not live in the home but the home has 24-hour staffing coverage, and a staff person who can make needed decisions is always present in the home.
