### Personal Care

"Personal care services" means both physical assistance and/or prompting and supervising the performance of direct personal care tasks as determined by the resident's needs, and does not include assistance with tasks performed by a licensed health professional. (WAC 388-76-10000)

#### 1. EATING

If needed, the home may provide assistance with eating as follows:

**feed the resident or chop the food so that the resident can be chew it easily.**

#### 2. TOILETING

If needed, the home may provide assistance with toileting as follows:

**walking to the bathroom and assist with undress and dress, or using Briefs or pull ups as needed.**

#### 3. WALKING

If needed, the home may provide assistance with walking as follows:

**assist walking the resident or by using devices like cane or walker as needed.**

#### 4. TRANSFERRING

If needed, the home may provide assistance with transferring as follows:

**transferring from bed to chair or chair to bed as needed.**

#### 5. POSITIONING

If needed, the home may provide assistance with positioning as follows:

**we are going position the resident every 2 hours**

#### 6. PERSONAL HYGIENE

If needed, the home may provide assistance with personal hygiene as follows:

**shampoo as needed, brush their teeth or dentures twice a day.....**

#### 7. DRESSING

If needed, the home may provide assistance with dressing as follows:

**we'll help or dress the residents as needed**

#### 8. BATHING

If needed, the home may provide assistance with bathing as follows:

**shower will be given between 9am-9pm at least once a week**

#### 9. ADDITIONAL COMMENTS REGARDING PERSONAL CARE

**we are willing to assist the resident with ADL everyday as needed.**

### Medication Services

If the home admits residents who need medication assistance or medication administration services by a legally authorized person, the home must have systems in place to ensure the services provided meet the medication needs of each resident and meet all laws and rules relating to medications. (WAC 388-76-10430)

The type and amount of medication assistance provided by the home is:

**passing prescribed medications by certified or delegated certified nurse assistant or delegated resident manager**

### Skilled Nursing Services and Nurse Delegation

If the home identifies that a resident has a need for nursing care and the home is not able to provide the care per chapter 18.79 RCW, the home must contract with a nurse currently licensed in the state of Washington to provide the nursing care and service, or hire or contract with a nurse to provide nurse delegation. (WAC 388-76-10405)

The home provides the following skilled nursing services:

**oral hygien and denture,light sponge bath, showers as required, dressing and undressing,assist with eating,incontinence care, toileting etc.**

The home has the ability to provide the following skilled nursing services by delegation:

**pass medication and insulin.**

### Staffing

The home's provider or entity representative must live in the home, or employ or have a contract with a resident manager who lives in the home and is responsible for the care and services of each resident at all times. The provider, entity representative, or resident manager is exempt from the requirement to live in the home if the home has 24-hour staffing coverage and a staff person who can make needed decisions is always present in the home. (WAC 388-76-10040)

- The provider lives in the home.
- A resident manager lives in the home and is responsible for the care and services of each resident at all times.
- The provider, entity representative, or resident manager does not live in the home but the home has 24-hour staffing coverage, and a staff person who can make needed decisions is always present in the home.
